MINUTES OF REGULAR MEETING BOARD OF EDUCATION SESSER-VALIER COMMUNITY UNIT SCHOOL DISTRICT NO. 196 MAY 9, 2016 6:00 PM

CALL TO ORDER

A regular meeting of the Board of Education of Sesser-Valier Community Unit School District No. 196 was held in the High School Library at 6:00 PM on Monday, May 9, 2016. The meeting was called to order by President Carroll Kelly.

PUBLIC COMMENT & CORRESPONDENCE

President Kelly asked for any visitor's comments. None were forthcoming.

Superintendent Henry presented a thank you note from the family of Sarah Burgess for the expression of sympathy.

REPORTS

LABORERS' LOCAL 773: No report

CUSTODIAL & MAINTENANCE SUPERVISOR: Brandon Dilliner, Maintenance Supervisor, presented information to the board regarding the list of projects for this summer that was presented to the board for approval. Discussion followed regarding the different projects including the replacement of kitchen equipment and heating and air conditioning control panel. Superintendent Henry explained that these projects will be funded through the Capital Projects Fund (1% County Sales Tax Revenue) which carries a healthy balance but is restricted to capital project expenses.

K-8 PRINCIPAL: Mrs. Logsdon, Elementary/JH Principal, presented the elementary/junior high information regarding the following to the board: Trust fund, special recognitions, upcoming

activities and events, Student Engagement Highlight, and JH graduation information. Mrs. Logsdon also presented a copy of the most recent edition of the S-V Happenings. She then asked the board members to let her know who wanted to participate in the junior high graduation and to also let her know how many reserved seats they each wanted.

H.S. PRINCIPAL: Mrs. Page, High School Principal, presented information regarding the following to the board: Trust fund, recent activities, special recognition for students, Advanced Placement (AP) courses, Student Engagement Highlight, and upcoming activities. She also asked the board members that wish to participate and/or need reserved seating to the high school graduation to contact the school.

SUPERINTENDENT: Mr. Henry, Superintendent, presented the following information to the board:

- 1. The consent agenda for this month's meeting includes the following additional item(s):
 - Approval of 2015-2016 Final Public School Calendar;
 - Authorization of the 2015-2016 tentative amended district budget;
 - Scheduling of a budget hearing for the 2015-2016
- 2. Board members were presented a copy of a Freedom of Information Act (FOIA) request that was received on April 12, 2016, and the district's response to it.
- 3. A copy of the district's annual Health/Life/Safety report from Regional Office of Education #21 was presented to the board. Superintendent Henry informed the board members that Mr. Dilliner handles this task for the district, and that he does a very good job working with the ROE #21 inspector and the state fire marshall.
- 4. As the Spring, 2016, legislative session winds down, it appears that there are some signs that the legislature could come to agreement on a Fiscal Year 2017 state budget. Bipartisan compromise has been occurring in Springfield for the last couple of weeks (e.g. agreement on higher education funding), and legislators have an incentive to come to agreement on a budget with an upcoming statewide election.

That said, of the two school funding proposals that have surfaced in the last 6 weeks or so (the Rauner plan and the Manar plan), neither seem to have enough support to be adopted unless there is a major breakthrough in 1) a revenue stream (i.e. tax increase) and/or 2) ideology regarding hold-harmless provisions. At this time, Superintendent Henry indicated that he did not think there will be a reliable estimate of General State Aid until mid-summer, at the earliest.

Superintendent Henry presented information regarding the School District Amended Budget Summary, indicating that the increase in the Education Fund expenses from the original budget was due mostly to an increase in out-of-school tuition.

He then discussed the information received from John Shadowens, former Director of The H Group, who is now Director at the United Methodist Children's Home. Mr. Shadowens informed Superintendent Henry about a possible grant that would include neighboring school districts to provide counseling services to our students. Superintendent Henry indicated that he will be bringing more information before the board members for approval next month.

Superintendent Henry presented information regarding contact from Dr. Kim Byars, Franklin-Jefferson Special Education Director, about the possibility of renting room space from S-V. He explained that the advantage of this arrangement would not only include the rent income, but would reduce transportation cost if any of the district's students are in any of the programs offered.
