REPORTS

SVEA: R. Payne reported on the recent activities, fundraisers, and prom. All school staff members enjoyed treats that were brought in for Teacher Appreciation Week. Payne noted that there will be an upcoming negotiations meeting.

CUSTODIAL & MAINTENANCE SUPERVISOR: No report.

K-8 PRINCIPAL: Mr. Jones, Elementary/JH Principal, presented the elementary/junior high information regarding the following to the board: Trust fund, upcoming events, recent activities, and junior high school awards banquet and graduation.

H.S. PRINCIPAL: Mrs. Page, High School Principal, presented information regarding the following to the board: Trust fund, upcoming activities, and special recognition for students. Page gave the board an update on student vaping and drug testing throughout the school and included a handout with her principal's report. Increase in staff visibility as well as reinstating the rule of "teacher sign-off" to the student's planner have helped. The Illinois State Police came

and gave detailed presentation to students on drugs/vaping and the effects. Officers with canines performed a random "sweep" of the school building and student parking lot. The district has also increased drug testing. Page recently attended "Catch Your Breath," which is a training program to help with vaping/drug use, and the district will receive two free vape detectors as a result.
