NEW BUSINESS

ADMINISTRATION OF OATH OF OFFICE FOR NEWLY-ELECTED SCHOOL BOARD MEMBERS: President Chris Gore administered the Oath of Office for the newly-elected school board members Glenn Gulley, Roger Hicks, Brent Loucks and Donald Robbins, Jr.

NOMINATION & ELECTION OF BOARD PRESIDENT: At President Gore's request, District Superintendent Jason D. Henry opened the floor for nominations for board president. Stacey nominated Chris Gore for board president. Superintendent Henry called for nominations two additional times; none were forthcoming. A motion was made by Stacey and seconded by Robbins to close the nominations for board president.

Voting was as follows: All voted yea. There being seven (7) yeas and zero (0) nays, the president declared that the motion carried.

Superintendent Henry asked for board members in favor of electing nominee Chris Gore for board president to raise their right hand.

All members voted for Chris Gore. Superintendent Henry declared that Chris Gore was elected board president. Mr. Gore then presided over the remainder of the meeting.

President Gore called for nominations two additional times; none were forthcoming. A motion was made by Stacey and seconded by Robbins to close nominations for board vice-president.

President Gore asked for board members in favor of electing nominee Carroll Kelly for board vice-president to signify by saying "aye".

All members present voted for Carroll Kelly. President Gore declared that Carroll Kelly was elected as board vice-president.

APPOINTMENT OF BOARD REPRESENTATIVE FOR FRANKLIN-JEFFERSON SPECIAL EDUCATION DISTRICT NO 801 GOVERNING BOARD (GORE, CHRIS): A motion was made by Gulley and seconded by Stacey to appoint, by resolution, Chris Gore as board representative for the Franklin-Jefferson Special Education District No. 801 Governing Board.
