

### Notice of Proposed Property Tax Increase for Sesser-Valier Community Unit School District No. 196

I. A public hearing to approve a proposed property tax levy increase for Sesser-Valier Community Unit School District No. 196 for 2013 will be held on December 9, 2013, at 5:20 PM at Sesser-Valier High School, 4626 State Highway 154, Sesser, Illinois.

II. The corporate and special purpose property taxes extended or abated for 2012 were \$1,070,385.81.

The proposed corporate and special purpose property taxes to be levied for 2013 are \$1,177,425.00. This represents a 10.00% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2012 were \$129,298.18.

The estimated property taxes to be levied for debt service and public building commission leases for 2013 are \$129,300.00. This represents a 0.00% increase over the previous year.

IV. The total property taxes extended or abated for 2012 were \$1,199,712.02.


The estimated total property taxes to be levied for 2013 are \$1,306,725.00. This represents a 8.92% increase over the previous year.
