CALL TO ORDER

A regular meeting of the Board of Education of Sesser-Valier Community Unit School District No. 196 was held in the High School Library at 6:00 PM on Monday, December 12, 2016. The meeting was called to order by President Carroll Kelly.

PUBLIC COMMENT & CORRESPONDENCE

Kevin Acosta wanted to thank Mrs. Logsdon for encouraging students to apply for the scholarships offered through the VFW. He indicated that two applications were received and processed through the local VFW and sent on to the district level. The applicants were not recipients of the scholarships, but the local veterans have decided to give each applicant \$50.00. Kevin asked Mrs. Logsdon to try and schedule a date that a couple of veterans could come to the school to present the money to the applicants (hopefully to encourage more participation in the future).

Glenn Gulley wanted to also thank Mrs. Logsdon for taking care of a situation he had brought to her attention.

H.S. PRINCIPAL: Mrs. Logsdon, in the absence of Mrs. Page, High School Principal, presented information regarding the following to the board: Trust fund, upcoming calendar entries, list of students receiving special achievements and awards, zSpace Update, information on the upcoming S-V Holiday Tournament, and report on past events.

SUPERINTENDENT: Mr. Henry, Superintendent, presented the following information to the board:

- 1. The consent agenda for this month's meeting includes the following additional item(s):
 - Approval of Teen REACH field trips;
 - Adoption of a resolution referencing disposition of obsolete school equipment;
 - Approval of the 2016 tax levy resolutions.
- 2. Mrs. Page, Mrs. Logsdon, and Mr. Henry will present student performance data (2016 school report card) at the regular January, 2017, board meeting.
- 3. The most recent indications out of Springfield signal legislative observers that a full-year budget for entities reliant on state monies (other than education) will not be adopted. Similarly, the long-expected income tax increase that most education advocates expected in January, 2017, will likely not pass either.

Despite a promise of stable education funding and a purported increase in general state aid, the State of Illinois has not made any Fiscal Year 2017 mandated categorical payments to school districts as of this writing. In fact, the State has not yet made the 4th quarter payment for FY 16 (no payments since April 27, 2016). As a result, school districts like ours are operating on a revenue stream that is, in fact, less than last year's revenue-to-date.

- 4. Superintendent Henry presented two (2) FOIA requests that the district recently received. The district's responses were also included.

A similar amount of state payments for Fiscal Year 2017 are now due & payable to the school district (the current year's MCATs). In less than a month (end of December), the State of Illinois will be behind on two (2) FY17 MCAT payments if payments don't start fairly soon.

Superintendent Henry also presented information regarding a proposal (regarding the distributing of information on a Click Card) from the pharmacy at the Sesser Clinic. He indicated that he will research and bring back to the board at a later date.

APPROVAL OF SUPERINTENDENT'S PARTICIPATION IN A.A.S.A. NATIONAL CONFERENCE: A motion was made by Loucks and seconded by Gulley to authorize the district superintendent's participation in the American Association of School Administrators 2017 National Conference on Education.

OTHER BUSINESS:

Superintendent Henry summarized the tax levy process and timelines. He then informed the board that a round of board policy updates will be presented in January and February (the final adoption date of updates) and indicated to the board policy committee members that he felt, so far in the revisions, that the changes can be handled through the mail without a meeting (if it looks different than expected, a meeting will be scheduled between the January and February board meetings).

Superintendent Henry also indicated that he would like to schedule a Deficit Reduction Committee meeting for immediately after the January, 2017, board meeting to review the amended budget.

ADJOURNMENT: A motion was made by Stacey and seconded by Gulley to adjourn.
