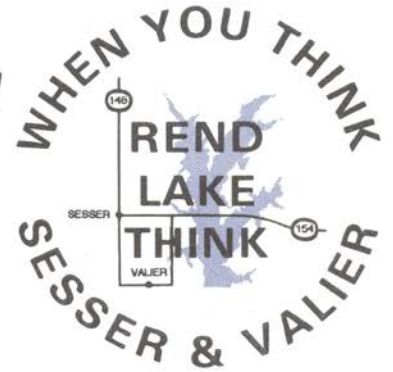

**Notice of Proposed Property Tax Increase for
Sesser-Valier Community Unit School District No. 196**

- I. A public hearing to approve a proposed property tax levy increase for Sesser-Valier Community Unit School District No. 196 for 2018 will be held on December 10, 2018, at 5:50 PM at Sesser-Valier High School, 4626 State Highway 154, Sesser, Illinois.

- II. The corporate and special purpose property taxes extended or abated for 2017 were \$1,241,341.47.

The proposed corporate and special purpose property taxes to be levied for 2018 are \$1,365,475.00. This represents a 10.00% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2017 were \$133,590.64.

The estimated property taxes to be levied for debt service and public building commission leases for 2018 are \$132,985.11. This represents a 0.46% decrease over the previous year.

- IV. The total property taxes extended or abated for 2017 were \$1,374,932.11.

The estimated total property taxes to be levied for 2018 are \$1,498,460.11. This represents an 8.98% increase over the previous year.
