**Notice of Proposed Property Tax Increase for  
Sesser-Valier Community Unit School District No. 196**

- I. A public hearing to approve a proposed property tax levy increase for Sesser-Valier Community Unit School District No. 196 for 2019 will be held on December 9, 2019, at 5:50 PM at Sesser-Valier High School, 4626 State Highway 154, Sesser, Illinois.

- II. The corporate and special purpose property taxes extended or abated for 2018 were \$1,288,517.71.

The proposed corporate and special purpose property taxes to be levied for 2019 are \$1,417,340.00. This represents a 10.00% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2018 were \$132,998.55.

The estimated property taxes to be levied for debt service and public building commission leases for 2019 are \$130,580.00. This represents a 1.82% decrease over the previous year.

- IV. The total property taxes extended or abated for 2018 were \$1,421,516.26.

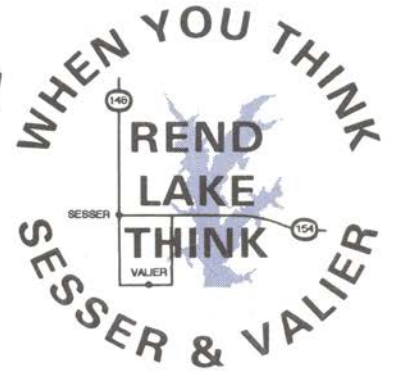
The estimated total property taxes to be levied for 2019 are \$1,547,920.00. This represents an 8.89% increase over the previous year.
