## **OATH OF OFFICE**

Superintendent Henry administered the Board's Oath of Office to new Board Members Garner, Lance, and Packer. All new board members affirmed the oath.

## **NEW BUSINESS**

## **ELECTION OF BOARD OFFICERS**

Superintendent Henry opened the floor for nominations for Board President. Spence nominated Jason Sample for Board President. Superintendent Henry called for any additional nominations three more times, and none were forthcoming. A motion was made by Spence and seconded by Menser to close nominations for board president.

Voting was as follows: All voted yea. There being seven (7) yeas and zero (0) nays, Superintendent Henry declared that the motion carried.

Superintendent Henry asked all those in favor of electing Jason Sample as board president to raise their right hands. All seven board members voted to elect Jason Sample as board president, and Superintendent Henry declared that Mr. Sample had been elected. Sample presided over the remainder of the meeting.

Sample opened the floor for nominations for Board Vice-President. Spence nominated Jennifer Menser for Board Vice-President. Lance nominated Kirk Packer for Board Vice-President. Sample called for any additional nominations three more times, and none were forthcoming. A motion was made by Spence and seconded by Barry to close nominations for board vice-president.

Voting was as follows: All voted yea. There being seven (7) yeas and zero (0) nays, the board president declared that the motion carried.

Sample asked all those in favor of electing Jennifer Menser as board vice-president to raise their right hands. Three board members voted for Menser. Sample asked all those in favor of electing Kirk Packer as board vice-president to raise their right hands. Four board members voted for Packer. Sample declared that Mr. Packer had been elected.

Sample opened the floor for nominations for Board Secretary. Sample nominated John Spence for Board Secretary. Sample called for any additional nominations three more times, and none were forthcoming. A motion was made by Barry and seconded by Menser to close nominations for board secretary.
